RESOLUTION 4.4 a) - ESTABLISHMENT OF S-LIAISON STATUS FOR ULCT/PPTM PROJECTS

SC 21 recommends, subject to the approval by JTC 1 National Bodies of the extension of S-liaison status to specified projects in SCs, that SC 21 should invite and encourage EWOS, AOW and OIW to request S-liaison status on Upper Layer conformance test (ULCT) and Protocol Profile Testing methodology (PPTM) projects:

1.21.35 on Session, Presentation, ACSE, CCR and VT test suite development;

1.21.41 on FTAM test suite development

and on

1.21.23.8 Protocol Profile Testing methodology (PPTM)

and that such S-liaison status should be granted when requested. This is in recognition of the abstract test suite development and protocol profile test development work now under-way in the regional workshops and that the ULCT and PPTM groups need to build upon this work which might otherwise be delayed in coming to the notice of SC 21 experts or which may never come at all. Furthermore, by granting such S-liaison status it is expected that additional expertise will be made available to assist in the work of the ULCT and PPTM groups.

RESOLUTION 4.4 b) - ESTABLISHMENT OF S-LIAISON STATUS FOR ULCT/PPTM PROJECTS

SC 21 recommends, subject to the approval by JTC 1 National Bodies of the extension of S-liaison status to specified projects in SCs, that SC 21 should invite and encourage EWOS, AOW and OIW to request S-liaison status on OSI Management Profile development.

RESOLUTIONS 9 AND 14 OF EWOS/TA14,
3-4 SEPTEMBER 1991

9. EWOS/EG NM recommends that EWOS requests the S-liaison status for liaison with JTC 1/SC21 on project 1.21.28 (OSI Systems management).

22. The EWOS/TA approves the establishment of an S-Liaison between EWOS/EG TP and ISO/IEC JTC1/SC21/WG1-5-6 in the area of OSI TP and CCR Conformance Testing (refer to Resolution 4.4a of the SC21 plenary meeting, 4-5 June, 1991).

The EWOS/TA instructs the EWOS secretariat to take the appropriate actions for establishing this liaison.
