WG 1

Resolution 2017.01: Progression to DIS of ISO/IEC 30113-5 "Information technology -- Gesture-based interfaces across devices and methods - Part 5: Gesture Interface Markup Language (GIML)"

ISO/IEC JTC 1/SC 35

- requests Dr. Sunghan Kim to send the disposition of comments on 2nd CD ballot for part 5 of the Gesture-based interfaces project completed in Berlin alongside the DIS document that results to the WG1 list with copy to WG5 and WG6 before 2017-03-15, for expert comments to be posted before 2017-03-31,
- requests Dr. Sunghan Kim to send the resulting document to the secretariat for DIS ballot not later than 2017-04-07,
- consequently requests the Secretariat to send it as an outcome to ITTF no later than 2017-04-14 for a 12 weeks DIS ballot, and a translation period of 8 weeks.

Resolution 2017.02: NP on ISO/IEC 30113-61 "Information technology -Gesture-based interfaces across devices and methods Part 61: Single-point gestures for screen readers"

ISO/IEC JTC 1/SC 35

requests Mr. Song Jaeil to send the revised WD for part 61 of the Gesture-based interfaces
project to the WG1 list of experts with copies to WG 4 list of experts, WG5 list of experts and
WG6 list of experts before 2017-06-30 for discussion at the next meeting.

Resolution 2017.03: NP on a universal interface for choosing a natural language

ISO/IEC JTC 1/SC 35

- requests Mr. Keld Simonsen to prepare a WD including at least the table of contents and ideally a requirements text, to accompany the draft NP prepared in Berlin on a universal interface for choosing a natural language in I.T. applications. This WD should be sent to the WG1, WG 2 and WG 5 list of experts before 2017-04-30 alongside with the cleaned-up NP document prepared in Berlin,
- requests the experts to provide comments to the same lists before 2017-05-31,
- requests Mr Keld Simonsen to revise the draft as appropriate and send the resulting documents to the same lists of experts again before 2017-06-30 for discussion at the next meeting, so that an 8-week NP ballot be initiated in consequence,
- requests experts to propose a new universal symbol to be registered in ISO 7000 that would represent the universal natural language selector in I.T. applications. This symbol may be the most important element of the interface,
- WG 1 will work with WG 2 and 5 in close cooperation on this topic.

Resolution 2017.04: NP on keyboard input methods

- requests Mr. Keld Simonsen to prepare a WD including at least the table of contents and ideally a requirements text, to accompany the draft NP prepared in Berlin on keyboard input methods. This WD should be sent to the WG1 list of experts before 2017-04-30 alongside with the cleaned-up NP document prepared in Berlin,
- requests the experts to provide comments to the same list before 2017-05-31,
- requests Mr Keld Simonsen to revise the draft as appropriate and send the resulting documents to the same list of experts again before 2017-06-30 for discussion at the next meeting, so that an 8-week NP ballot be initiated in consequence.

Resolution 2017.05: NP on standardizing keyboard "group selection"

ISO/IEC JTC 1/SC 35

- requests Mr. Keld Simonsen to prepare a WD including at least the table of contents and ideally a requirements text, to accompany the draft NP prepared in Berlin on standardizing keyboard "group selection". This WD should be sent to the WG1 list of experts before 2017-04-30 alongside with the cleaned-up NP document prepared in Berlin.
- requests the experts to provide comments to the same list before 2017-05-31.
- requests Mr Keld Simonsen to revise the draft as appropriate and send the resulting documents to the same list of experts again before 2017-06-30 for discussion at the next meeting, so that an 8-week NP ballot be initiated in consequence.

Resolution 2017.06: Amendment 1 of ISO/IEC 9995-9

ISO/IEC JTC 1/SC 35

- approves a subdivision of ISO/IEC 9995-9 project to produce its amendment 1,
- requests Mr. Karl Pentzlin
 - o to add in this document any text which ensures compatibility with the new part of the ISO-IEC 9995 on "group selection" as requested by the resolution 2017-05 above,
 - to revise the specification of the group YC as specified in paragraph B.16 of the current version of that standard, assigning the Russian Ruble sign at an appropriate place in that group even if this requires moving of other currency signs, and to assign all other currency signs added to ISO/IEC 10646 (Unicode) since the last version considered of ISO/IEC 10646 an appropriate place in ISO/IEC 9995-9,
 - o to add other characters added to ISO/IEC 10646 (Unicode) since the last ISO/IEC 10646 version considered, at an appropriate place in ISO/IEC 9995-9,
 - o to replace the reference to PUA (Private Use Area of ISO/IEC 10646) where appropriate.

Resolution 2017.07: Preparing a future NP on ISO/IEC 30113-12 "Information technology -- Gesture-based interfaces across devices and methods – Part 12: Multi-point gestures for common system action"

ISO/IEC JTC 1/SC 35

requests Dr Hyuk Jeong to send the NP form and new WD for part 12 of the Gesture-based interfaces project to the WG1 list with copy to WG5 and WG6 before 2017-06-30, for expert discussion at the next July meeting, so that an 8-week NP ballot be initiated in consequence. The WD should include a solution to the alternative mode selection issue discussed at the Seoul meeting (multi-point mode activated with only one finger).

Resolution 2017.08: SC35 symbols to be included in ISO/IEC 10646

- requests Mr. Karl Pentzlin to update document SC35 N 1579. Modifications would be restricted to
 - adding all symbols defined in ISO/IEC 9995-10
 - dropping any symbols which can be unified with Unicode characters encoded in the meantime
 - adjust the proposed codepoints to free ones in cases where the originally proposed codepoints have been assigned to other characters in the meantime.
- requests Mr. Pentzlin to submit the updated document to the SC35 secretariat no later than 2017-02-28,
- requests the SC35 Secretariat to submit it directly to JTC1/SC2 as a liaison proposal to SC2 after receiving the document.

 - discussions on the progress of "ISO/IEC PWI 20071-31 Information technology User interface component accessibility - Guidance on making content 'Easy To Read' ".
 - discussions with ITU representatives relating to their possible adoption of parts of the ISO/IEC 20071 series.

Resolution 2017.27: Definition of "accessibility"

ISO/IEC JTC1/SC35

 recognizes the new definition of accessibility adopted by both ISO TC159 and ISO TC159/SC4 to replace their previous definitions and that this new definition was adapted from SC35 Resolution 2011.73:

accessibility

extent to which products, systems, services, environments and facilities can be used by people from a population with the widest range of user needs, characteristics and capabilities to achieve identified goals in identified contexts of use

Note 1 to entry: Context of use includes direct use or use supported by assistive technologies.

• resolves to adopt this new definition and to use it, from this time forward, in all documents requiring a definition of accessibility.
