Resolution 2012.52: Progression of DIS 9995-10 "Information technology – Keyboard layouts for text and office systems -- Part 10: Conventional symbols and methods to represent graphic characters not uniquely recognizable by their glyph on a keyboard and in documentation" to FDIS (WG1)

ISO/IEC JTC 1/SC 35 approves the disposition of comments (N 1906) on the DIS 9995-10 ballot and requests the Secretariat to submit document N 1907 provided by the project Editor Mr Karl Pentzlin after modification at the 2012 Paris WG1 meeting, to ITTF for FDIS ballot processing no later than 2012-09-30.

ISO/IEC JTC 1/SC 35 kindly requests Mr Karl Pentzlin to draft an NP and proposed CD for a future ISO/IEC 9995-11, as a partial response to the German request to revise the whole series of ISO/IEC 9995, which was published 2 years ago. This should be submitted to the Secretariat in time for a concurrent NP and CD ballot to start no later than 2012-09-30.

SC 35 requests WG 1 to further follow-up the German request, no later than after the publication of potential ISO/IEC 9995-11.

SC 35 also recognizes that many different standards bodies are interested in or working on this topic.

Because of the importance of this area to the user interface community, ISO/IEC JTC 1/SC 35 requests to collaborate on the revision of ISO/IEC 24751 and invites ISO/IEC JTC 1/SC 36 to have a joint discussion on appropriate ways of collaborating on their ISO/IEC 24751 project. SC 35 would appreciate a response suggesting a collaboration mechanism by 2012-10-31.

^{1.15.1} Within each organization, technical committees **and/or subcommittees** working in related fields shall establish and maintain liaison.

^{1.15.3} A technical committee or **subcommittee may designate an observer**, or observers, to follow the work of another technical committee with which a liaison has been established, or one or several of its subcommittees. **The designation of such observers shall be notified to the secretariat of the committee concerned,** which shall communicate all relevant documents to the observer or observers and to the secretariat of that technical committee or subcommittee.

^{1.15.4} Such observers shall have the right to participate in the meetings of the technical committee or subcommittee whose work they have been designated to follow but shall not have the right to vote. They may contribute to the discussion in meetings, including the submission of written comments, on matters within the competence of their own technical committee. They may also attend meetings of working groups of the technical committee or subcommittee if they so request.
