**Modification to "Proposed Statement of Scope of ISO/IEC
JTCl/SGFS (N 2027)**

Document N 2256 includes memberbody comment on N 2027. In cooperation with Italian, Japanese and US delegates the following changes are proposed to N 2027 to incorporate these comments.

1 - Delete the clause '(SGFS, no ...)' in the title.

2 - Start the layout of the text as follows:

SCOPE
Functional Standardization in the field of...

3 - First line of item 3 Change 'D' to 'd'

4 - Split item number 3 of SCOPE in two parts as follows:

3. Definition of a methodology for achieving functional standardization

4. Preparation of International Standardized Profiles (ISPs), in accordance with user requirements (An ISP is defined as: ... etc.: the text between brackets remains unchanged)

* The number of scopes 4-7 are increased by one.

5 - Replace item 7 (as per N 2027) by the following:
8. development of an expeditions approval process.

6 - Change the sentence "Note: Excluded __ SGFS are:"
to "Excluded:"

7 - Replace the final paragraphe of SCOPE by:

The area of functional standardization includes that of the domain of Open Systems Interconnection (OSI) and that of the development of Application Environment Profiles (AEPs) within the Open Systems Environment (OSE).

8 - Replace the REPRESENTATION paragraph with the following text:

ISO and IEC Councils have authorized the following organizational participation in SGFS:

ISO representatives,
IEC representatives,
"A" liaison organizational representatives of the JTCl SGFS,
"S" liaison organizational representatives of the JTCl SGFS
involved in the work of functional standardization.
