Dear Alan,

For several years, ISO has applied criteria according to which ISO/IEC JTC 1 standards may, on the request of the committee, be made available free of charge on the web. The IEC Council Board (CB) originally decided to proceed differently, and to take a decision case by case on whether a standard might be made available free of charge or not.

Recently, the Council Board asked an *ad hoc* group led by Mr Yumoto of Japan to re-examine the situation and to propose an efficient procedure for dealing with such requests from JTC 1. At its meeting this month, the CB accepted the group's recommendations, the decision reading:

"Criteria for availability free of charge on the WWW of JTC 1 Publications

CB DECISION 2003/016

Acknowledging with appreciation the efforts of the task force headed by CB Member Mr Yumoto, and stressing that this should be applicable to JTC 1 only, the Council Board <u>approved</u> the criteria according to which JTC 1 Publications may be released free of charge on the WWW, as summarized in Annex.

In addition, the Council Board <u>invites</u> the ISO Council to concur with this decision so that the release procedures can be harmonized between the two organizations."

As you will see in the Annex, many of the criteria are identical to those in ISO Council Resolution 50/1999; the others seemed to the CB to complete the intentions of the process and therefore to be desirable additions. There was also one restriction decided with respect to the ISO criteria: not all Technical Reports but just a subset of Type 3 TRs will correspond to the IEC criteria.

May I kindly request that you deal with the CB's invitation within ISO as you deem appropriate?
