ISO/IEC JTC1/SC 35 Plenary meeting, 2018-08-27/31 Okayama, Japan – Resolutions

WG 1

Resolution 2018-09: Progress of ISO/IEC 22121-2: "Information technology -- Virtual keyboards user interfaces -- Part 2: Virtual keyboards interactions"

ISO/IEC JTC 1/SC 35

- requests ISO/CS to renumber it to ISO/IEC 22121-3 (to avoid potential confusion see resolution 2018-10).
- requests the ISO/IEC JTC 1/SC 35 Secretary to take necessary actions to reset the project as a PWI no later than 2018-09-30.

Unanimously approved

Resolution 2018-10: Renaming ISO/IEC 22121-1 "Information technology -- Virtual keyboards user interfaces -- Part 1: Generic interface"

ISO/IEC JTC 1/SC 35

- acknowledges that the generic framework for this whole series of standards will have to be
 developed after its main parts, given that current part 1 focuses on the most used instance of virtual
 keyboards and not on the more general case.
- requests the ISO/IEC JTC 1/SC 35 Secretary to take the necessary actions to change this project's title
 from "Information technology -- Virtual keyboards user interfaces -- Part 1: Generic interface" to
 "Information technology -- Virtual keyboard user interfaces -- Part 2: On-screen keyboards with
 direct touch interface".

Resolution 2018-11: CD ballot on ISO/IEC 22121-2 "Information technology – Virtual keyboard user interfaces -- Part 2: On-screen keyboards with direct touch interface"

ISO/IEC JTC 1/SC 35

- requests the editor, Mr Thibault Grouas, to provide a new text to the ISO/IEC JTC 1/SC 35 Secretary no later than 2018-10-01 taking into account changes made during Okayama ISO/IEC JTC 1/SC 35/WG 1 meeting.
- requests the ISO/IEC JTC 1/SC 35 Secretary to launch a 12-week CD ballot with this text no later than 2018-10-05 so that ballot results be ready before the next ISO/IEC JTC 1/SC 35/WG 1 meeting.

Resolution 2018-12: ISO/IEC 9995-9:2016/PDAM 1 "Information technology -- Keyboard layouts for text and office systems -- Part 9: Multi-lingual, multiscript keyboard layouts -- Amendment 1"

ISO/IEC JTC 1/SC 35

- acknowledges the positive results of the PDAM 1 ballot that came back approved unanimously without any comment.
- requests ISO/IEC JTC 1/SC 35 Secretary to take appropriate action to launch the DAM 1 ballot no later than 2018-09-07 with the unmodified text.

Resolution 2018-13: Progress of ISO/IEC 9995-12 "Information technology - Keyboard layouts for text and office systems - Part 12: Keyboard group selection"

ISO/IEC JTC 1/SC 35

- requests the editor, Mr Keld Simonsen, to send ISO/IEC JTC 1/SC 35 Secretary a new text incorporating changes made during the meeting, alongside the disposition of comments, no later than 2018-10-01.
- requests the ISO/IEC JTC 1/SC 35 Secretary to launch the second CD ballot no later than 2018-10-05 so that ballot results be ready before the next ISO/IEC JTC 1/SC 35/WG 1 meeting

Resolution 2018- 14: Expected Follow-up on input methods

ISO/IEC JTC 1/SC 35

- accepts the recommendation of Mr Keld Simonsen to put this potential project on hold, so that it can be rethought.
- requests Mr Keld Simonsen to investigate (for example in the Linux world) on how to achieve this standard and report at the next meeting the results of this investigation with a recommendation as to how it can be furthered on or not at this point.
- requests Mr Keld Simonsen to send a working draft to ISO/IEC JTC 1/SC 35/WG 1 Convenor no later than 2018-12-31.
- requests the convenor, Mr Alain LaBonté, to circulate this text at the latest one month before the next WG1 meeting for presentation.

Resolution 2018-15: Postponing the second amendment of ISO/IEC 9995-7 "Information technology -- Keyboard layouts for text and office systems -- Part 7: Symbols used to represent functions"

ISO/IEC JTC 1/SC 35

• requests Mr Karl Pentzlin to present his case about PDAM 2 to ISO/IEC 9995-7 at the next ISO/IEC JTC /SC 35/WG 1 meeting, as text received was not considered mature enough by the experts in absence of discussion. This amendment is therefore put on hold until that discussion occurs.

Resolution 2018-16: Postponing the amendment of ISO/IEC 9995-10 "Information technology -- Keyboard layouts for text and office systems -- Part 10: Conventional symbols and methods to represent graphic characters not uniquely recognizable by their glyph on keyboards and in documentation"

ISO/IEC JTC 1/SC 35

 requests Mr Karl Pentzlin to present his case about PDAM 1 to ISO/IEC 9995-10 at the next ISO/IEC JTC 1/SC 35/WG 1 meeting, as text received was not considered mature enough by the experts in absence of discussion. This amendment is therefore put on hold until that discussion occurs. Resolution 2018-17: Tools for encoding ISO/IEC 9995-7 "Information technology -- Keyboard layouts for text and office systems -- Part 7: Symbols used to represent functions" and ISO/IEC 9995-10 "Information technology -- Keyboard layouts for text and office systems -- Part 10: Conventional symbols and methods to represent graphic characters not uniquely recognizable by their glyph on keyboards and in documentation"

As a follow-up of resolutions 2010.47 and 2010.48, taking into account ISO/IEC JTC1/SC2 refusal to encode some codepoints corresponding to extra symbols of ISO/IEC 9995,

ISO/IEC JTC 1/SC 35

- acknowledges the wish of Mr Karl Pentzlin, the creator and rights holder of the fonts made for the ISO/IEC 9995-7 amendments 1 and 2 and for ISO/IEC 9995-10, that these be freely available for all uses and that they be downloadable from the public ISO/IEC JTC 1/SC 35 web site.
- requests ISO/IEC JTC 1/SC 35 Secretary to take the necessary actions to this end.
- kindly asks Mr Karl Pentzlin to prepare a document showing correspondence of ISO/IEC 9995-7 and 9995-10 symbols with ISO/IEC 10646 characters and assigned PUA codepoints (PUA=Private Use Area), also showing glyphs used in the latter and symbols used in the former.
- kindly asks ISO/CS to setup a publicly available download area for easy access to these fonts and the correspondence document.

 Alternative text, as already defined in ISO/IEC 20071-11, is within the scope of ISO/IEC JTC 1/SC 35, which is currently making significant revisions to ISO/IEC 20071-11. It is inappropriate for ISO TC159/SC4/WG10 to proceed as it intends.
- asks ISO TC159/SC4 to require its WG 10 to cease work on this proposed work item.
- requests its Chair to contact the Chair of ISO/TC 159/SC 4 regarding this matter.
