

Resolutions of the December 1992 authorized subgroup meeting of JTC1/SGFS in London

Resolution 1 - ENDORSEMENT OF LIAISON STATEMENTS

SGFS approves the following liaison statements and instructs its secretariat to forward these as appropriate:

Resolution 2 - PUBLICATION OF TR 10000-2:1992

SGFS instructs its secretariat to forward SGFS N 748 to the ISO/IEC ITTF as final text for publication as TR 10000-2:1992 with a change in title to "Information technology - Framework and taxonomy of International Standardized Profiles - Part 2: Taxonomy of OSI Profiles".

Resolution 3 - PROGRESSION OF TR 10000 PARTS 1, 2, and 3

SGFS instructs the editors of TR 10000 parts 1, 2, and 3 to develop revised working drafts of the respective parts as per the editors' instructions contained in SGFS N 756, and to forward revised working drafts to the SGFS secretariat. SGFS further instructs its secretariat to circulate the revised working drafts to National Bodies, liaison organizations, and other ISO/IEC SCs/TCs involved in OSE work, for review and comments prior to April 30, 1993.

Resolution 4 - REVISED VERSION OF SD-1, SGFS PROCEDURES

SGFS instructs the editor of SGFS SD-1 to produce a new version, SFGS N 757, based on agreements made during the SGFS Authorized Subgroup Meeting in London, December 1992. SGFS

resolves to use this document as its current SD-1.

#### Resolution 5 - FUTURE PROCEDURES DOCUMENT FOR INTER-TC OPERATIONS

SGFS instructs the editor of SGFS SD-1 to produce a proposed future procedures document, SGFS N758, including inter-TC operations. SGFS further instructs its secretariat to forward this document to National Bodies and liaison organizations for comments prior to the July 1993 meeting of SGFS at which meeting the document is expected to be sent out for ballot.

#### Resolution 6 - APPLICABILITY OF JTC1 DEFECT CORRECTION PROCEDURE

In response to specific requests (ref. SGFS N 734, comment 7) on the applicability of the JTC1 Defect Correction Procedure, clause 6.13.3, the SGFS confirms that

- 1) it is possible to amend an ISP by using the JTC1 Defect Correction Procedure
- 2) the JTC1 Defect Correction Procedure is not reserved to progressing amendments to ISPs resulting only from base standard defects

#### Resolution 7 - PROFILE ATTRIBUTES

In response to the issues raised in SGFS N615, SGFS encourages the RWSs to prepare and forward technical contributions in areas of ISP work even when the taxonomy implications of profile attributes are not fully resolved, e.g. for managed objects, security, routing etc.

#### Resolution 8 - UPDATES TO PUBLISHED FODxx ISPs

SGFS instructs its secretariat to notify the submitting organizations of FOD11, FOD26, and FOD36 of the need to provide Defect Reports and associated proposed corrections to published profiles resulting from the changes to FOD taxonomy (introduction of FOD011, FOD026 and FOD036).

#### Resolution 9 - APPRECIATIONS
