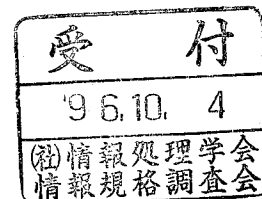
RESOLUTION M6.1 (Continuation of IRG rapporteur)**Unanimous**

RESOLUTION M6.13 (Withdrawal of ISO 8957)

Unanimous

JTC 1/SC 2 supports the request from the national body of Israel to withdraw ISO 8957 on Hebrew Alphabet Coded Character Sets for Bibliographic Information Interchange for the reasons given in document JTC 1/SC 2 N 2702. JTC 1/SC 2 further invites ISO TC 46 to use existing JTC 1/SC 2-developed standards in their projects, in particular ISO/IEC 10646-1.

RESOLUTION M6.14 (Transfer of TC 46 coded character set standards)

Unanimous

With reference to the ISO Technical Management Board resolution number 83/1995 (in document JTC 1/SC 2 N 2681) JTC 1/SC 2 requests JTC 1 to invite ISO TC 46 to transfer their current DIS-s listed in document JTC 1/SC 2 N 2681, to JTC 1 and assign them to JTC 1/SC 2 for completion and future maintenance. Further, JTC 1/SC 2 requests JTC 1 to invite ISO TC 46 to transfer their current work items on **coded** character sets to JTC 1 and assign them to JTC 1/SC 2.

RESOLUTION M6.15 (Voting discipline of P-members)

SC 2 requests ITTF to inform P-members of SC 2 who fail to vote on three consecutive SC 2 ballots, of the automatic change in their status, in accordance with article 3.1.3 of the JTC 1 Directives.

RESOLUTION M6.17 (Electronic Communications in SC 2)

SC 2 notes document N 2675 on 'The Revised JTC 1 Policy on Electronic Document Distribution'. However, due to its special needs SC 2 will continue its current experiments with electronic distribution in SC 2 and its working groups. Further, SC 2 appoints Mr. Keld Simonsen to represent it at the next meeting of the ad hoc group on JTC 1 Strategy for Implementing IT, at the end of September 1996, in London, England.

RESOLUTION M6.18 (Next Meeting)

SC 2 schedules its Seventh Plenary meeting tentatively during the week of 20th of June 1997, in Cyprus (to be confirmed), to be co-located with the SC 2 /WG 2 meeting.

RESOLUTION M6.6 (Question on Vertical Extension A)

Unanimous

SC 2 instructs its secretariat to send the question in resolution M31.11 in document N2747 from WG 2, to the SC 2 membership along with supplementary information on the population of the BMP, for response to the WG 2 convener by 15 November 1996.

RESOLUTION M6.7 (Revision of 7350)

Ireland - Abstain; Denmark, Canada - NO

SC 2 instructs its project editor to prepare the first CD text for the revision of ISO/IEC 7350 and submit it to the SC 2 secretariat for concurrent registration and CD ballot.

RESOLUTION M6.8 (Progression of 8859 parts)

Unanimous

SC 2 instructs its project editors to prepare the final CD texts for the revision of ISO/IEC 8859 Parts 1 to 6, 9 and 10, and submit them to the SC 2 secretariat for progressing to DIS ballot.

RESOLUTION M6.9 (Third CD of 1073-2)

Unanimous

SC 2 instructs its project editor to prepare the third CD text for the revision of ISO 1073-2 and submit it to the SC 2 secretariat for CD ballot.

RESOLUTION M6.10 (Request for New Liaison)

Unanimous

SC 2 accepts the request, and instructs its secretariat to request JTC 1 to approve the following Category B - liaison to:

CCSDS - Consultative Committee on Space Data Systems

as requested in document N 2738.

RESOLUTION M6.11 (The Internet Society - cooperation agreement)

Unanimous

SC 2 accepts the proposed cooperation agreement with the Internet Society in document N 2739 in principle, with some reservations on the feasibility of using electronic information interchange as indicated at the end of clause 3, due to the nature of SC 2 standards. SC 2 instructs its secretariat to return the modified agreement for acceptance by the Internet Society and approval by JTC 1.

RESOLUTION M6.12 (CEN/TC304 - draft cooperation plan)

Canada - Abstain; Netherlands - NO

SC 2 accepts the draft cooperation plan between SC 2 and CEN/TC304 as given in document N 2743 and invites contributions from CEN/TC304 on SC 2 projects.
