Comments accompanying the approval vote for ISO/IEC <u>10646-1:1993</u>-FDAM 23-Comments: 1. The title of Table 50 - Row 30 on pages 114 and 115 (pages 1 and 2 of the ballot document SC2 N3194) is incorrect. It should be: CJK SYMBOLS AND PUNCTUATION. 2. The glyph at position U+31AC is incorrect. The overhang line

at the upper left corner should be removed. See SC2 N3112 for the correct form of the glyph.
