**JTC 1 Matters:**

**Resolution 12-01: Recommendation for five years periodical review**

SC 2 notes that the standards listed in document N 3631 and N 3670 are subject to JTC 1 five years periodic review in 2003 and 2004 respectively and recommends to JTC 1 as follows:
