Resolutions of the 6th RWS-CC Meeting
in Brussels on October 14/15, 1991

1. In response to the approval of extension of S-liaisonship to JTC1, the RWS-CC request to the chair to collect lists of SIG's/EG's from each RWS by the end of November 1991 and to send the list to all related SC's of JTC1 (SC2, SC6, SC18, SC21, SC22, SC27).
2. All the documents published by RWS's are confirmed to be usable without copyright restriction for ISP harmonization activity by RWS's.
3. The RWS-CC requests the chair to negotiate with the ISO central secretariat for the right of publication of ISP's by RWS's. The right is important for smooth dissemination of ISP related information as a part of RWS activity, including dissemination of information using electronic means. The draft of the letter is to be circulated among three RWS's.
4. The RWS-CC notes the importance of the subject of Application Portability. The role of RWS's for contributions and harmonization of Application Portability Profiles via SGFS should be discussed in the next RWS-CC meeting. The RWS-CC requests AOW and OIW to consider possibilities to expand functions to include OSE by the next RWS-CC meeting.
5. The RWS-CC requests Directory RSIG's to accelerate the activity toward harmonized profiles. Progress will be reviewed at the next RWS-CC meeting.
6. The RWS-CC agrees on the revised list of "ISP activities" given in Annex 1.
7. The RWS-CC agrees on the list of harmonization of non-ISP items given in Annex 2.
8. From 7th RWS-CC a new column will be included in Annex 2 table to indicate future disposition of the matter.
9. The RWS-CC supports the concept of an RWS-CC series of reports for some harmonized non-ISP specifications.

The RWS's are requested to discuss practical implications and report to the next RWS-CC meeting.

10. The RWS-CC recognized the importance of harmonized FSTS. To consider the problems in each RWS, EWOS is requested to send related information to other RWS's. If ATS is included in the material, the source of the document should be clearly indicated.
11. The RWS-CC agreed to include work plan for the development of FSTS in the Annex 3. The maintenance of the table will be discussed in the next RWS-CC meeting.
12. When representatives from RWS's are to attend International Technical Assemblies (e.g. RWS meetings, ISO meetings), representation of RWS should be clearly indicated.
13. SGFS new procedure manual has been published. All RWS's and SIG's/EG's should take notice of the new procedure manual (SGFS N-401/N-415).
14. The RWS-CC notes addition of annex 4 which includes the list of contact points and future meeting schedule of each RWS's. The list should includes e-mail addresses.
15. The RWS-CC encourages the 3 RWS's to develop International Standard Profiles (ISP's) under the following general guidelines, (1) to avoid the unnecessary proliferation of profiles, (2) to avoid duplication of profiles, (3) to ensure that profiles are appropriate, and (4) to ensure that profiles are correct and complete. This guide line should be applied in particular to the construction of proper taxonomy.
16. Log of actions related to the resolutions of RWS-CC meetings will be included as Annex 5 of the resolutions.
17. The RWS-CC thanks EWOS for hosting the present meeting.
18. The next meeting of RWS-CC will be held on April 2-3, 1992 in Kyoto, Japan.
19. Tentative schedule of 8th RWS-CC is Sept. 28-29, 1992 in Washington DC Area.
