A SGFS ballot resolution meeting on DTR 10000-2 was held during the June 1992 meeting of JTC 1/SGFS. The Calling notice for the meeting was distributed to the SGFS mailing-list on April 15, 1992.

Tables of National Body ballot replies and comments were contained in JTC 1/SGFS N 522.

Agreement could be reached that a revised version of the editors interim version should be progressed for publication.

There was unanimous agreement by all National Bodies present, to use the MHS taxonomy as provided in contribution SGFS N530 as a replacement for the outdated MHS taxonomy in clause 5.3.2. This action was considered as appropriate resolution of the UK ballot comment. It was noted that SGFS N530 has been endorsed by all workshops. This approach was preferred over other options such as deleting the outdated MHS taxonomy clause or marking it as unstable.

The following National Bodies were present at the ballot resolution meeting: Belgium, Canada, Denmark, France, Germany, Republic of Korea, Netherlands, UK, U.S.

The annexed table summarizes the comments received and their resolution.
