

TITLE: U.S. comments on ISO/IEC TR10000-1 as documented in ISO/IEC JTC1/SGFS N1282.

STATUS: For consideration at the 12th ISO/IEC JTC1/SGFS Plenary Meeting, June 17th - 21st, 1996, Tokyo, Japan.

The U.S. has reviewed ISO/IEC TR10000-1 as documented in ISO/IEC JTC1/SGFS N1282, the JTC1 Guidelines on the use of Reference Specifications in ISPs (JTC1 N4047 = SGFS N1341) and the SGFS comments on RS (SGFS N1309). Based on this review, the U.S. Provides the following comments:

- 1 CLAUSE 2: The JTC1 Guidelines on the use of RS in ISPs should be included.
- 2 CLAUSE 4: RS should be added to the list of Abbreviations.
- 3 CLAUSE 6.1: Text must be added to this clause, particularly subclause 6.1.2, to reflect the ability to utilize Reference Specifications. For example, the first paragraph of Clause 6.1.2 should be updated to reflect the option of use of RS. This opening paragraph should be followed by text which points the reader to the JTC1 Guidelines.
- 4 CLAUSE A.3.3, FOREWORD: SGFS N 1309, Clause 4.2.3, identifies that TR10000-1 should be updated to stress the need for harmonization. Guidance on this should be given in the instructions on what to include in the foreword of an ISP. Text similar to that in the SD-1 can be used.
- 5 CLAUSE A.4.2, POINT b, SCOPE - POSITION WITHIN THE TAXONOMY: SGFS N1309, Clause 4.2.3, identifies that TR10000-1 should be updated to stress the importance of having a position in the taxonomy. This point should be made in this subclause.
- 6 CLAUSE A.4.2, SCOPE: The material identified in SGFS N 1309, clause 4.2.2, must be incorporated into TR10000-1. A logical place for this material, which would identify requirements from the JTC1 Guidelines, is in TR10000-1 Clause 4 on General normative elements. Subclause A.4.2 is one possible place for such text, possibly as an additional point "d)".
- 7 CLAUSE A.4.3, NORMATIVE REFERENCES: SGFS N 1309, Clause 4.2.3, identifies that TR10000-1 should be updated to stress the preference for PAS transposition as opposed to the use of RS. This note should be included in clause A.4.3 and should be similar to the text used in SD-1.
- 8 CLAUSE A.4.3, NORMATIVE REFERENCES: SGFS N 1309, Clause 4.2.1, identifies text to be added to ISPs using RS. This text needs to be incorporated into TR10000-1 Clause A.4.3.
